Principles of data processing

Personal data is any information relating to an identified or identifiable natural person. This includes, for example, information such as your name, age, address, telephone number, date of birth or e-mail address. Information for which we cannot (or can only with a disproportionate effort) establish a link to your person, e.g. by anonymizing the information, is not personal data.

The processing of personal data (e.g. collection, retrieval, use, storage or transmission) always requires a legal basis or your consent. Processed personal data will be deleted as soon as the purpose of the processing has been achieved and there are no longer any legally required retention obligations.

If we process your personal data for the provision of certain offers, we will inform you below about the specific procedures, the scope and purpose of the data processing, the legal basis for the processing and the respective storage period.

1. Sponsorships

a. Type and scope of data processing

On this sponsorship form we offer you the possibility to take over a sponsorship. The following overview shows you in detail which personal data we process from you during a sponsorship:

If you give a SEPA - direct debit mandate, we collect the following data:

- Account holder (first name and last name)
- Credit institution
- BIC
- IBAN

b. Legal basis

The processing of the personal data presented is based on the declaration of consent voluntarily given by you in accordance with Art. 6 (1) lit. a DSGVO. Since a sponsorship contract with Ewaka Germany e.V. is concluded by submitting the form for association membership, the processing of the personal data presented also serves the fulfillment of a contract between you and Ewaka Germany e.V., or the implementation of pre-contractual measures, in accordance with Art. 6 (1) lit. b DSGVO.

c. Storage period

We store your sponsorship data for a maximum of 6 years from the end of the sponsorship due to a statutory retention period. After that, all data will be deleted, unless the data must be stored for 10 years for tax reasons.

2. Passing on of data

We will only pass on your personal data to third parties if:

- You have given your express consent to this in accordance with Art. 6 para. 1 p. 1 lit. a DSGVO,
- if there is a legal obligation for the transfer according to Art. 6 para. 1 p. 1 lit. c DSGVO,
- this is legally permissible and necessary for the fulfillment of a contractual relationship with you according to Art. 6 para. 1 p. 1 lit. b DSGVO,
- the disclosure is made in accordance with Art. 6 Para. 1 S. 1 lit. f DSGVO due to a legitimate interest of our association and there is no reason to assume that you have an overriding interest worthy of protection in the non-disclosure of your data.

3. Data security and security measures

We undertake to protect your privacy and to treat your personal data confidentially. To prevent manipulation, loss or misuse of your data stored with us, we take extensive technical and organizational security precautions, which are regularly reviewed and adapted to technological progress.

1) SEPA Mandat

- B. If you want to terminate or pause the sponsorship, please write us an e-mail in time, because this way we can plan with the loss of the sponsorship.
